- Membership fees cannot be refunded under any circumstances.
- All services and facilities provided by Chinese YMCA of Hong Kong are for members only. Members must present valid membership cards before participating in activities, using facilities and services.
- Chinese YMCA of Hong Kong will provide Personal Accident Coverage for members who participate in all Chinese YMCA of Hong Kong activities. The eligibility of coverage is subject to the insurance policy.
- Life Members and Supporting Members whose membership cards are either lost or damaged can apply for replacement membership cards free of charge through Corporate Communications & Marketing Section of Chinese YMCA of Hong Kong. Other members would have to re-apply and pay HK\$10 for a replacement membership card. The validity period for replacement membership cards remains unchanged.
- Members can renew their membership within three months prior to their membership expiry dates. The effective date will be started from the date of expiry. Members are eligible to apply for a 1-year, 3-year or 5-year membership.
- If members wish to access to or make changes to their personal data, please contact or submit a written request to Chinese YMCA of Hong Kong.
- Any man of the Chinese race who is baptised Christian upon verification by pastor and is 18 years old or above, recommended by the Protestant Voting Member or Secretary of the Association, can be a Protestant Voting Member. He is eligible to participate in annual general meeting and elect directors of Chinese YMCA of Hong Kong (Except Allied School Membership and Group Membership). Please note that applicants should fill in either the date of baptism or the name of baptising pastor in the membership application form.
